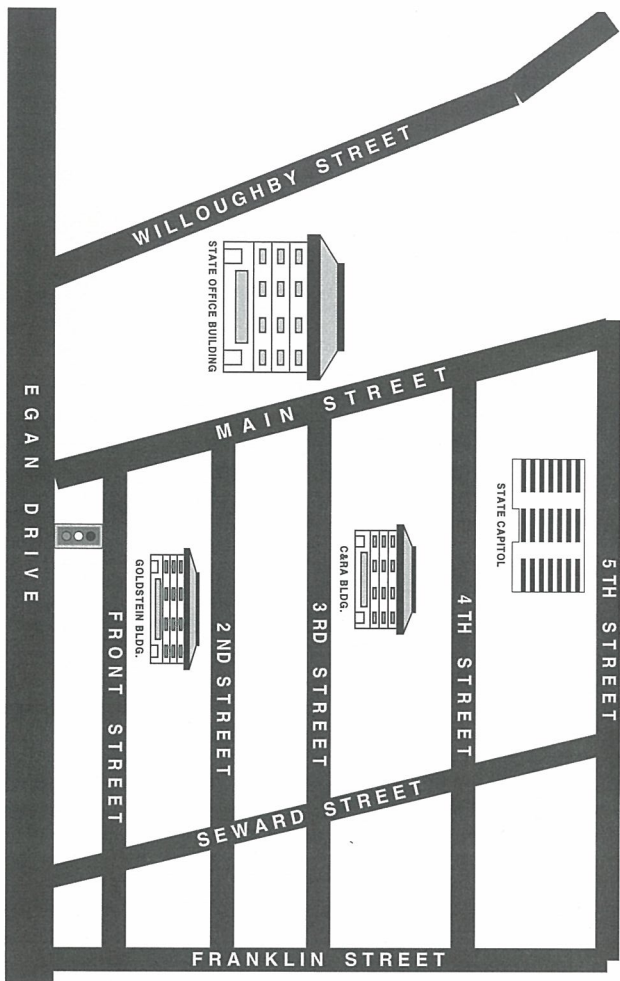
GENERAL INFORMATION
