# ALASKA LEGISLATURE

## 2025 SALARY AND BUSINESS EXPENSE REPORT

### OVERVIEW

This report is filed in accordance with Alaska Statute Sec. 24.10.120(b) and includes amounts received by legislators and legislative directors, or paid to third parties on their behalf, for authorized business expenses and salaries during calendar year 2025.

Legislators expend funds throughout the calendar year in the performance of their duties. Expenses are reimbursed for receipted expenditures or paid directly to third parties. Part A of this report shows expenses based on the calendar year in which the expense was paid, and Part B further delineates whether an expense incurred in calendar year 2024 (Year Expense Incurred column).

### TRAVEL EXPENSES

Legislators in travel status to a place other than their place of permanent residence are reimbursed a short term per diem rate or actual lodging expenses plus a meal allowance to cover costs associated with their business travel.

Legislators are entitled to reimbursement for conference fees, business phone calls made while in travel status, or other business-related travel expenses.

Legislator travel and mileage reimbursement figures vary greatly depending on district location (e.g., on or off the road system) and official responsibilities and are therefore not comparable.

### RELOCATION EXPENSES

Per the Legislative Council Moving and Travel Policy, legislators' personal moving and travel expenses necessary to attend legislative sessions are provided as follows: (a) the cost of transportation to and from the Capital City for a legislator, as well as any spouse and/or dependents; (b) one vehicle; and (c) household goods and personal effects up to 3,000 pounds. The cost varies depending on the method(s) of transportation available and the weight of personal household goods needed for session. For instance, it is more expensive to ship a car from remote locations than to drive a vehicle to Juneau. Relocation for families for a special session are covered in this section, while legislators are included under travel.

Relocation expenses from one individual legislator to another vary greatly due to the distance and limited shipping and travel methods available from the more remote parts of Alaska to the State Capital. As such, relocation expenses for legislators from different districts should not be compared.

Legislators may or may not relocate their families to Juneau for the session. The relocation expenses for legislators with large families should not be compared to single legislators, legislators with small families, or legislators who choose not to relocate their families to Juneau.

## 2025 SALARY AND BUSINESS EXPENSE REPORT

### SESSION PER DIEM

The Legislative Council Travel and Per Diem Policy states that legislators, except those whose place of permanent residence is within 50 miles of the Capitol or the meeting site of a special session, are entitled to a daily per diem at the winter federal rate in effect at the beginning of each regular legislative session.

In 2025, legislators convened for 120 days in the regular session. Fifty-seven legislators were reimbursed \$332 per day from January 21, 2025, through May 20, 2025; and three Juneau legislators received no session per diem.

The First Special Session of the Thirty-Fourth Legislature convened on August 2, 2025 and ended on August 31, 2025 and lasted for 30 days. Legislators were able to claim per diem at the rate of \$332 for one day.

### OFFICE ACCOUNT EXPENSES

Per Alaska Statute Sec. 24.10.110, legislators receive an annual allowance for postage, stationery, stenographic services, and other business expenses. Senators receive up to \$20,000 and Representatives receive up to \$12,000. The allowance is administered under an accountable plan, which means all invoices and receipts claimed are submitted to the Legislative Affairs Agency for processing.

### SALARY

The Alaska State Officers Compensation Commission, per AS 39.23.540(a), provided an amended recommendation at its March 15, 2023, meeting that legislator salaries be increased to \$84,000 annually. The President of the Senate and the Speaker of the House of Representatives receive an additional \$500 per year during tenure of office, therefore, their salary amounts should not be compared with other legislators.
