GENERAL INFORMATION

The House of Representatives and the Senate convene at 10:00 a.m. daily unless a different time is agreed upon by the body. House and Senate chambers are located on the second floor of the Capitol.

Calendars, bills and resolutions, daily journals, announcements and a printed status of bills and resolutions (published weekly) are available at Documents, Room 5, Capitol.

The Juneau Legislative Information Office, Room 111, Terry Miller Building, can provide information on the legislative process and the current status of bills and resolutions, roster of members, seating charts, Uniform Rules, and the printed reports of the Legislature and its agencies.



The First Territorial Legislature met on March 3, 1913. It consisted of 8 senators and 16 representatives elected from all across Alaska. They convened at the Elks Lodge in downtown Juneau until the current Capitol was completed in 1931.

The very first act of the First Territorial Legislature in 1913 gave women the right to vote, several years before Congress took any such action.

The Territorial Legislature pushed Alaska closer to statehood often facing great struggles with the federal government.
