Chapter 1 CORPORATE USE OF REMOTE COMMUNICATION

Removes obstacles to the use of remote communication for certain actions taken by for-profit corporations under AS 10.06, non-profit corporations under AS 10.20, and business and industrial development corporations under AS 10.10.
(HCS CSSB 24(L&C))

Effective date: April 1, 2021, retroactive to March 11, 2020

Chapter 2 EXTENDING THE GOVERNOR'S DECLARATION OF DISASTER

Extending the governor's declaration of a public health disaster emergency in response to the COVID-19 pandemic to December 31, 2021. Making temporary enactments of law limiting the governor's authority during a declaration of emergency disaster, granting the commissioner of health and social services the ability to declare a public health emergency, approving a financing plan related to the state's response to the disaster declaration, requiring the Office of Management and Budget to prepare monthly reports detailing disaster-related expenditures, modifying professional and occupational licensing and fees, relaxing laws related to telemedicine and telehealth, permitting online charitable gaming sales, relaxing school operating fund requirements, creating a presumption of workers' compensability for employees who contract COVID-19, preventing fiscal year 2022 appropriations from being increased based upon federal emergency relief funding, granting civil and criminal immunity for government acts undertaken in good faith related to the disaster declaration, granting civil immunity to licensees and businesses practicing in substantial compliance with COVID-19 health mandates, restricting abortion funding, and permitting individuals to object to a COVID-19 vaccine.
(SCS CSHB 76(FIN) am S)

Effective Date: May 1, 2021; sections 1, 2(b) – (d), 3 – 10, 12, 13, and 16 – 21 are retroactive to February 14, 2021; sections 2(a) and 11 are retroactive to November 15, 2020; sections 14 and 15 are retroactive to March 11, 2020

Chapter 3 **FUNTER BAY MARINE PARK; UNANGAĀ CEMETERY IN FUNTER BAY**
Expands Funter Bay Marine Park to include the UnangaĀ cemetery in Funter Bay. Requires the Department of Natural Resources to amend the management plan for the Funter Bay marine park to protect the social and historical significance of the UnangaĀ cemetery. **(HB 10)**

Effective Date: June 9, 2021

Chapter 4 **ALLOCATION OF FUNDING FOR TECHNICAL AND VOCATIONAL EDUCATION AND CAPITAL IMPROVEMENTS**
Extending the current allocation formula of special employee unemployment contributions for the Alaska technical and vocational education program through the fiscal year ending June 30, 2024. **(HB 100)**

Effective Date: June 10, 2021

Chapter 5 **ALASKA REGIONAL ECONOMIC ASSISTANCE PROGRAM**
Extends the termination date of the Alaska regional economic assistance program to July 1, 2031. **(HB 192)**

Effective Date: June 10, 2021

Chapter 6 **BOARD OF CERTIFIED DIRECT-ENTRY MIDWIVES**
Extends the termination date of the Board of Certified Direct-Entry Midwives to June 30, 2023. **(HB 117)**

Effective Date: June 10, 2021

Chapter 7 **EXTENDING THE FISHERY RESOURCE LANDING TAX CREDIT**
Extends the repeal of the fishery resource landing tax credit for taxpayers that harvest fishery resources under the provisions of a community development quota from December 30, 2020, to December 30, 2030. **(HB 182)**

Effective Date: June 10, 2021; retroactive to December 30, 2020

Chapter 8 **BOARD OF PUBLIC ACCOUNTANCY**
Extends the termination date of the Board of Public Accountancy to June 30, 2029. **(HB 126)**

Effective Date: June 10, 2021

Chapter 9**CONTRIBUTIONS OF THE STATE AS AN EMPLOYER TO THE PUBLIC EMPLOYEES' RETIREMENT SYSTEM**

Requiring that the state as an employer contribute every payroll period to the Public Employees' Retirement System enough to pay the employer normal cost, the required contributions for the State of Alaska Teachers' and Public Employees' Retiree Health Reimbursement Arrangement Plan and the defined contribution retirement plan, and the past service cost for members as determined by the Alaska Retirement Management Board. Authorizing the commissioner of administration to adopt regulations to implement the Act. (SB 55)

Effective Date: Section 3 takes effect June 10, 2021; remainder of Act takes effect July 1, 2021

Chapter 10**AQUATIC FARMING AND HATCHERY SITE LEASES**

Directs the Department of Natural Resources to, in cooperation with the Department of Game, provide a report to the legislature by January 20, 2022, concerning aquatic farming site leases, possible improvements to related leasing procedures, and the economic dimensions of the state's aquatic farming sector. Requires the director of the division of lands to provide the legislature an annual report relating to the department's treatment of site lease applications for aquatic farming. Changes the procedure for renewal or extension of an aquatic farming and related hatchery operation site lease. Provides that a person leasing a site for aquatic farming and related hatchery operations may also use that site for a related tourism enterprise or educational purpose. Prohibits the Department of Natural Resources from charging a lessee, sublessee, or other person assigned all or a part of an aquatic farm site lease, a fee for using the site for a tourism enterprise or educational purpose relating to aquatic farming. (SCS HB 115(RES))

Effective Date: September 13, 2021

Chapter 11**CREDIT FOR REINSURANCE**

Adds conditions that a qualified reinsurer must meet to assume the liabilities of a domestic insurer. Defines "reciprocal jurisdiction" and requires the director of the division of insurance to consider the list of the reciprocal jurisdictions published through the National Association of Insurance Commissioners committee process in determining a reciprocal jurisdiction. Authorizes the director to approve a jurisdiction not on the list and to remove a jurisdiction on the list. (SB 87)

Effective Date: Section 5 takes effect June 19, 2021; remainder of Act takes effect September 16, 2021

Chapter 12 SPECIAL EDUCATION SERVICE AGENCY

Amends the funding formula for the Special Education Service Agency, and extends the agency through June 30, 2029. **(CSSB 19(FIN))**

Effective Date: Section 1 takes effect July 1, 2021; remainder of Act takes effect June 30, 2021

Chapter 13 RENEWABLE ENERGY GENERATION; EXEMPTION FROM REGULATION AS A PUBLIC UTILITY

Extends until July 1, 2028, the exemption from regulation as a public utility for plants and facilities first placed into commercial operation after August 30, 2010, that generate electricity entirely from renewable energy resources. Clarifies that otherwise exempt plants and facilities are subject to regulation under AS 42.05.760 - 42.050.790, sections requiring and regulating electric reliability organizations. **(SB 69 am)**

Effective Date: July 1, 2021

Chapter 14 OPIOID OVERDOSE DRUGS

Allows the chief medical officer to continue issuing standing orders for the prescription of an opioid overdose drug by removing a June 30, 2021, statutory deadline for the expiration of those orders. Directs the Department of Health and Social Services to complete an annual report to the legislature describing activities and expenditures related to opioid overdose drug distribution. **(CSSB 70(HSS))**

Effective Date: June 30, 2021

Chapter 15 RAW MILK; SHARED OWNERSHIP OF MILK-PRODUCING ANIMALS

Authorizes a part owner of a milk-producing animal to pay or reimburse another owner for costs related to the animal or sharing its raw milk or raw milk products. Allows a part owner to directly share raw milk or raw milk products from the animal with another part owner who provides certain contact information. Prohibits the Department of Environmental Conservation from imposing additional restrictions or requirements on sharing or transferring raw milk or raw milk products among part owners. **(HB 22 am)**

Effective Date: September 29, 2021

RELATING TO CARE OF JUVENILES AND TO JUVENILE JUSTICE; RELATING TO THE DETENTION OF MINORS; RELATING TO MINORS SUBJECT TO ADULT COURTS; RELATING TO THE PLACEMENT OF MINORS IN ADULT CORRECTIONAL FACILITIES; RELATING TO MANDATORY REPORTERS OF CHILD ABUSE OR NEGLECT; RELATING TO SEXUAL ASSAULT IN THE THIRD DEGREE; RELATING TO SEXUAL ASSAULT IN THE FOURTH DEGREE; REPEALING A REQUIREMENT FOR ADMINISTRATIVE REVOCATION OF A MINOR'S DRIVER'S LICENSE, PERMIT, PRIVILEGE TO DRIVE, OR PRIVILEGE TO OBTAIN A LICENSE FOR CONSUMPTION OR POSSESSION OF ALCOHOL OR DRUGS

Amends the terminology used in the juvenile delinquency statutes, and makes corresponding changes in other statutes relating to juveniles, including statutes relating to sex offenses, medical marijuana, overtime limitations for nurses, and children in need of aid. Expands the definition of "position of authority" for purposes of the sex offense statutes. Amends the offense of indecent viewing to exclude exposure in treatment facilities or treatment institutions from the definition of "private exposure." Requires provision of special education to children with disabilities at juvenile detention facilities and juvenile treatment facilities. Entitles an indigent minor who has been waived into adult court and is being held at an adult correctional facility to representation at a review hearing under AS 47.12.105(d). Requires the commissioner of corrections to enter into an agreement with the Department of Health and Social Services for the detention and care of minors waived into adult court. Requires a court to issue a written order including certain findings when a minor is placed in a juvenile detention facility as a result of violating a court order. Makes the Alaska Delinquency Rules and the statutes on delinquent minors inapplicable where a person under the age of 21 is accused of consumption or possession of alcohol; to these violations shall be charged, prosecuted, and sentenced in district court. Creates a new section relating to the detention of minors waived into adult court which requires the transfer of minors to the department of corrections at 18 years of age, the separation by sight and sound of minors from adult offenders if a minor is held in an adult correctional facility for more than four hours, provides the factors a court must consider in making a determination that a minor waived into adult court is to be held in an adult correctional facility, provides for good time credit for minors held in secure juvenile facilities, and entitles a minor who has been waived into adult court and held in an adult correctional facility to counsel at review hearings. Amends the statute on court dispositional orders to allow detention in juvenile treatment facilities, juvenile detention facilities, and secure residential psychiatric treatment centers. Amends provisions relating to the detention of minors. Repeals and reenacts the employment of juvenile probation officers statute. Authorizes the Department of Corrections to disclose information necessary relating to the release of a minor or transfer of detention of a minor and correctional agency information necessary for a juvenile offender. Amends victim notification requirements. Enacts and amends definitions, including definitions for "juvenile detention facility," "minor juvenile probation officer," "juvenile treatment facility,"

"residential child care facility," and "temporary secure juvenile holding area." Amends powers of the Department of Health and Social Services to include jurisdiction over juvenile facilities. Makes juvenile probation officers, juvenile probation office staff, staff at a juvenile detention facility and juvenile treatment facility mandatory reporters. **(SCS CSHB 105(JUD))**

Effective Date: July 9, 2021

Chapter 17 MOTOR VEHICLE DEALERS

Requires an applicant for a license to operate as a dealer in motor vehicles to provide information regarding workers compensation insurance and liability insurance, and a statement that no person holding a five percent or greater interest in the business has been convicted of a felony involving fraud, embezzlement, or misappropriation of property during the five-year period immediately preceding the application. Requires motor vehicle dealers to identify themselves as motor vehicle dealers to persons who purchase vehicles from the motor vehicle dealer, requires motor vehicle dealers to maintain liability and property insurance. **(SCS HB 36(L&C))**

Effective Date: October 11, 2021

Chapter 18 HUNTS AWARDED BY DRAWING

Provides authority to the Department of Game to transfer a hunting permit for a hunt that was originally awarded to a state resident by drawing to a qualified substitute, if the person to whom the hunting permit was originally awarded dies before the hunt. A substitute must be a state resident selected by the decedent's spouse or immediate family member. **(CSSB 125(RES))**

Effective Date: July 14, 2021

Chapter 19 MASTER-GUIDE OUTFITTERS

Changes a qualification, relating to prior convictions for hunting offenses, for licensure as a master-guide outfitter. Makes a conforming change to Big Game Services Board licensing qualifications that requires the board to revoke the license of a master-guide outfitter who is convicted of certain hunting offenses. Applies these changes retroactively to September 14, 2019. **(CSSB 134(RES))**

Effective Date: July 14, 2021; sections 1 and 2 are retroactive to September 14, 2019

Chapter 20 ALASKA MARINE HIGHWAY OPERATIONS BOARD

Replaces the Alaska Marine Transportation Advisory Board with the Alaska Marine Highway Operations Board. Specifies the qualifications for members of the Alaska Marine Highway Operations Board, and establishes six-year terms for members.

Authorizes the presiding officers of the legislature to appoint four members of the board. Requires the board, in addition to carrying out the duties of the Alaska Marine Transportation Advisory Board, to provide advice and recommendations to the commissioner on the operation and management of the Alaska marine highway system as well as recommendations regarding preparation of the statewide transportation improvement plan, permits the board to recommend corrective action if the Alaska marine highway system has deviated from the short-term or comprehensive long-range plans, and authorizes the board to establish a task force. Requires the Department of Transportation and Public Facilities to respond to recommendations made by the Alaska Marine Highway Operations Board regarding the statewide transportation improvement program, and to report on the progress of the Alaska marine highway system in meeting the performance goals established by the Alaska Marine Highway Operations Board. Requires annual preparation of a short-term plan, and increases the scope of the comprehensive long-range plan for the development and improvement of the Alaska marine highway system, and requires that comprehensive long-range plan be incorporated into the comprehensive, intermodal, long-range transportation plan for the state. (SCS CSHB 63(TRA))

Effective Date: October 11, 2021

Chapter 21 NAMING THE IRENE WEBBER BRIDGE

Names bridge number 406 at mile 9.5 of the Copper River Highway the "Irene Webber Bridge." The "i" is intentionally lowercase, as that is how she spelled her name. (HB 27)

Effective Date: October 11, 2021

Chapter 22 STATE CONSTRUCTION SERVICES

Provides in the state procurement code a method for state agencies to obtain preconstruction and construction services using a construction manager general contractor approach. (CSHB 160(TRA) am)

Effective Date: Section 5 takes effect July 15, 2021; remainder of Act takes effect October 12, 2021

Chapter 23 BOARD OF GOVERNORS OF THE ALASKA BAR ASSOCIATION

Extends the termination date of the Board of Governors of the Alaska Bar Association to June 30, 2029. (SCS HB 109(JUD) am S)

Effective Date: July 22, 2021

Chapter 24 ELEMENTS OF MEDICAL MALPRACTICE

Requires that a plaintiff have a health care provider-patient relationship with the health care provider at the time the cause of action accrued in order to prove a claim for medical malpractice, and defines "health care provider-patient relationship." (HCS CSSB 65(JUD))

Effective Date: November 14, 2021

Chapter 25 ABANDONED VEHICLES

Decreases the amount of time an abandoned vehicle must be left standing or parked on private property without consent of the private property owner before title may be transferred from six months to 30 days. (SB 76)

Effective Date: November 14, 2021

Chapter 26 INTENSIVE MANAGEMENT HUNTING LICENSE SURCHARGE

Repeals the termination date for the intensive management hunting license surcharge. (SB 22)

Effective Date: November 23, 2021

Chapter 27 HOUSE RULES FOR ASSISTED LIVING HOMES

Modifies the requirements for assisted living homes to include a requirement that the home provide visitor access to its residents, internet access to its residents if available, meals consistent with residents' cultural preferences, communications in a language understandable to its residents, and quality care. Requires that house rules established by an assisted living home be consistent with 42 C.F.R. 441.301(c)(4). (HCS CSSB 89(HSS))

Effective Date: November 23, 2021

Chapter 28 LICENSE PLATES FOR PEOPLE WITH A DISABILITY

Permits speech-language pathologists, physical therapists, and occupational therapists to provide proof of disability that would enable a person to receive a license plate that displays the international symbol of accessibility (the wheelchair logo). (SB 47)

Effective Date: November 23, 2021

Chapter 29 OCCUPATIONAL LICENSING OF MEMBERS OF THE MILITARY AND THEIR SPOUSES; MOBILE INTENSIVE CARE PARAMEDICS

Requires the Department of Commerce, Community, and Economic Development or the appropriate licensing board to issue a temporary courtesy license to an active duty member of the armed forces of the United States or their spouse, within 30 days of receiving a completed application from a person who meets the requirements for the temporary courtesy license. Transfers licensing and oversight responsibility for mobile intensive care paramedics from the State Medical Board to the Department of Health and Social Services. **(HCS SB 21(L&C) am H)**

Effective Date: Section 19(c) takes effect August 26, 2021, remainder of Act takes effect January 1, 2022

Chapter 30 VIETNAM HELICOPTER PILOTS' MEMORIAL BRIDGE

Names bridge numbers 1124 and 1889 over the Matanuska River at mile 30.4 of the Glenn Highway the Vietnam Helicopter Pilots' Memorial Bridge. **(HB 34)**

Effective Date: November 26, 2021

Chapter 31 VETERANS' BENEFIT SERVICES AND VETERANS' BENEFIT APPEAL SERVICES

Requires persons who provide veterans' benefit services or veterans' benefit appeal services to disclose that those services are available at no cost from the Department of Military and Veterans' Affairs. This disclosure is required on an agreement to provide veterans' benefit services or veterans' benefit appeal services, and on advertisements for veterans' benefit services or veterans' benefit appeal services. Creates a civil penalty for non-compliance with the disclosure requirement. **(SB 40)**

Effective Date: November 26, 2021

Chapter 32 INDUSTRIAL HEMP

Requiring the commissioner of natural resources to permit the manufacturing and retail sale of industrial hemp and industrial hemp products and to establish a registration and renewal procedure for participants in the industrial hemp program. Requiring the commissioner of natural resources to notify the Marijuana Control Board and the Department of Public Safety when a stop order is issued. Amending stop order issuing requirements. Amending industrial hemp registration or renewal application requirements. Allowing a producer of industrial hemp whose product has a delta-9-tetrahydrocannabinol content between 0.3 percent and one percent to retain and recondition the product. Amending the definition of "industrial hemp." **(CSSB 27(RES))**

Effective Date: November 27, 2021; section 9 is conditional

Chapter 33 ESTABLISHING APRIL 24 OF EACH YEAR AS VIC FISCHER AND JACK COGHILL CONSTITUTION OF THE STATE OF ALASKA DAY

Establishes April 24 of each year as Vic Fischer and Jack Coghill Constitution of the State of Alaska Day to honor Jack Coghill, Vic Fischer, and the other delegates to the Alaska Constitutional Convention and commemorate the creation of the Constitution of the State of Alaska. **(HCS CSSB 28(STA))**

Effective Date: September 5, 2021

Chapter 34 COURTESY LICENSES FOR MILITARY SPOUSES
