COMMITTEE ISSUES ADVISORY OPINION 06-01

"Can a legislative employee, on a regular basis, receive personal mail at the State Capitol through a 'change of address' form?

On October 20, 2006 the ethics committee determined the following:

The chief purpose of the capitol mailroom is to process incoming and outgoing official mail for 60 legislators. In view of the important role that legislative employees play, and balancing the need for efficient operations of the capitol mailroom for legislators, the committee determined that "de minimis" personal use of capitol mailroom services by legislative employees is permitted under AS 24.60.030(a)(1)(A). "De minimis" means receipt of two to three pieces of personal mail per week or less. Submitting a 'change of address' card to the United States Post Office, for <u>all</u> personal mail to be

delivered to the State Capitol mailroom, is prohibited under the 'de minimis' exception.

For example, the receipt of an occasional package from Lands End, Ebay, or Amazon would be permitted, as well as the occasional letter. However, if personal mail starts to exceed the two to three pieces allowed per week, it is the responsibility of the legislative employee to notify the sender(s) to use an address other than the Capitol address for future mailings. Failure to do so in certain situations would result in a violation of the ethics code.

consist of a presentation and interactive sessions addressing core issues of preserving the public trust; i.e., using public office for personal gain, principles of accountability/transparency, conflicts of

interests, avoiding appearances of impropriety and special

challenges of following the spirit as well as the word of the law.

Mr. Josephson has a long history with the Alaska Legislature. He conducted an ethics workshop for legislators focusing on "Ethical Dimensions of Political Leadership" in 1988. He was subsequently hired by the Senate in 1990 to conduct an ethics opinion survey of legislators, nonlegislative public officials and lobbyists. Additionally, he reviewed current ethics laws and rules of the Alaska Legislature and recommended ethics legislation. Major changes to the ethics code were introduced in 1991 based on his recommendations. Mr.

Josephson testified before numerous Senate and House committees in 1991 and 1992. This ethics code is still in place today with a number of legislative changes made over the years.

Mr. Josephson will be contacting key legislators and the ethics committee chair for input prior to the workshop.
