MINUTES from June 16, 2015 FULL COMMITTEE MEETING Anchorage LIO, Conference Room 203

1. **CALL THE MEETING TO ORDER:** Committee Chair Dennis "Skip" Cook called the meeting to order at 9:00 a.m. Ethics Administrator Jerry D. Anderson took roll call:

- 2. **APPROVAL OF AGENDA:** Member Leask motioned to approve. No objections. Motion passed.
- 3. APPROVAL OF MINUTES:
